## Representative Matters

- Lead counsel and argued three cases before the United States Court of Appeals for the Fifth Circuit, including *Seeligson v. Devon Energy Production Co., LP*, 761 Fed.Appx. 329 (5<sup>th</sup> Cir. 2019) a royalty owner class action where the court largely affirmed the district court's core oil and gas findings and the case was ultimately certified after remand (see 804 Fed.Appx. 304 (5<sup>th</sup> Cir. 2020))
- Argued numerous other cases to intermediate Texas appellate courts, including one of two reported cases in Texas state courts concerning advancement of attorney's fees for an officer/director being sued by the company. *L Series, LLC v. Holt*, 571 S.W.3d 864 (Tex. App. Fort Worth 2019)
- Represented large international construction firm in successful one-week arbitration in arising out of cement plant project (September 2018)
- Federal jury verdict of more than \$33 million in breach of contract and tortious interference case, later reduced in favor of equitable relief and case settled following appeal (July 2018)
- Lead trial and appellate counsel representing royalty owners in 2012 suit against Chesapeake Energy Corporation regarding improper calculation and payment of royalties under an oil and gas lease. Obtained judgment for damages and attorney's fees for more than \$1 million. Later argued case before Texas Supreme Court, where the case ultimately resulted in a significant win for royalty owners in *Texas Chesapeake v. Hyder*, 483 S.W.3d 870 (Tex. 2016)
- Resolution of claims for liquidating trust of a bankrupt oil and gas company against the former CEO
- Lead trial counsel in bankruptcy trial in the U.S. Bankruptcy Court, District of Delaware, successfully defeated \$8 million claim against the Debtor's estate related to its facility that manufactured fire and emergency vehicles. *American LaFrance, LLC v. RT Jedburg Commerce Park, LLC*, No. 08-10178 (BLS), Adversary No. 10-51245, United States Bankruptcy Court, D. Del., *aff'd* Civ. No. 11-1273-RGA (U.S. District Court, D. Del. (2012))
- Lead trial counsel in federal fraud trial concerning the sale of fiber optic products. Obtained jury verdict of approximately \$12.5 million. *Kevin M. Ehringer Enterprises, Inc. v. McData Services Corporation*, No. 3:06-CV-812-L, U.S. District Court, Northern District of Texas; *rev'd* at 646 F.3d 321 (2011)
- Lead defense counsel representing oil and gas company in multiple suits arising out of wildfires that occurred in the Texas Panhandle in 2006. More than twelve separate cases were filed in six different counties with over 100 separate plaintiffs. *In re Cano Petroleum Wildfire Litigation*, No. 07-0593 (Tex. MDL 2008)
